**Low Sulphur Fuel Surcharge Effective 18<sup>th</sup> of June**

Dear Valued Customers,

NPDL wishes to advise that following monitoring of Low Sulphur Fuel (LSFO) price, for the last 2 months, effective 18<sup>th</sup> of June an updated Low Sulphur Fuel Surcharge will be applicable on all shipments. LSFO price has increased by more than 10% during the monitoring period, triggering the new tier of the surcharge.

- Australia to / from South Pacific and Norfolk Island will be USD \$76 / TEU
- New Zealand to / from South Pacific Islands will be USD \$52 / TEU
- Inter-Island will be USD \$105 / TEU
- **Reefers:** to be applied at a trade coefficient of 1.5 per TEU of dry
